Minutes:

Lorraine announced that there won't be any Girls In Science event this academic year. Minutes of July's board meeting were approved by consensus.

Gwen said **programming** is set and that we will be singing at the December meeting. Eau Claire's branch would like to attend our programs virtually. A discussion ensued on how best to include them, how to make the Zoom link available to anyone who would like to join. We can't refuse anyone (freedom of speech), but Zoom host can control participants who might be unduly disruptive. Elaine and Suzanne will work on getting a registration process set up so that everyone who is interested can register and automatically have the link sent to their email address. The Falcon Daily on the UWRF campus and the Community Ed site are also potential connecting points for posting info on our programs.

Fundraising We have donated \$1,000.00 to AAUW National in the past at the end of each year.

Since our normal fundraiser activities are cancelled, with no fundraising possibilities on the horizon, there was discussion on whether to cut back the amount of our donation, or to keep our donation at the same level as we have in the past. We have about \$4,200.00 total in our operating expense budget; \$2,500.00 in travel, and \$2,200.00 in scholarship funds.

In December we will give out \$550.00 for the CVTC scholarship and if NCWSSL goes, we will need funds for that as well.

It was moved and seconded that we still donate \$1,000.00, pulled from the travel budget, to National this year because of all the work they are doing to continue to educate members. We will bring the motion to the general meeting in November.

Several ideas were floated for fundraising: a monthly donation campaign, personal sponsors (for NCWSSL), an at home gala, a TED talk speaker, a virtual happy hour, or an un-auction.

There will be a small committee comprised of Kay, Lorraine, Gwen, Ann, and one or two non-board members to further plan and organize a fundraiser. Perhaps we could get facial coverings with the AAUW logo or Uff Da! printed on them as gifts for donors.

We could do events to coincide with March 8th, International Women's Day or Equal Pay Day in April, even opening it up to a community fundraiser.

In December it was suggested to focus on the program and just donate what you might have spent at the auction in another year.

Legacy Circle Ann G. presented information on an opportunity to make a planned gift to AAUW. This makes a commitment to helping women and girls even after we pass, done through the Legacy Circle. You can do this in many ways, any amount: through your will, a living trust, life insurance beneficiaries, etc. A financial advisor can help you do this. The money is not spent until after AAUW receives it. It's a win-win because there is no estate tax on gifts to charitable organizations, so your heirs aren't taxed on that amount, nor is the organization.

We have 3 Legacy members in our branch: Ann Gustafson, Kay Montgomery, and Jeanne Zirbel.

Other Items We are doing well after a few phone calls on membership renewals. And we have new members to our branch in spite of COVID.

Policy reminders from Barbara Peterson. Does anyone need help getting to the polls? Reach out to three people to see if they have already voted or intend to vote, if they need a ride to the polls. Reminder of the importance of donating to legislators. Think of giving to candidates even outside your district who you believe embody the AAUW values and principles. Post-election the Legislature will redistrict the State. Watch.

Tuesday, November 3rd 2020 is the Presidential Election.

In recent years AAUW-WI has been unsuccessful in encouraging our legislators to adopt issues that improve the condition of women and children in this state. It is unlikely to change until and unless we change the way our state divides legislative districts. Wisconsin ranks as the worst for gerrymandered districts. There are two excellent videos that explain how redistricting was handled in WI in 2011. I suggest you view them so you can better understand the unfairness of our current situation. Here is how you can do that:

- 1. The WI Farmers Union has published a 3-minute video that briefly describes how gerrymandering took place in WI. I am giving you the page that leads to the video. That page has some prime ideas for how to change the way redistricting is done. Click on the video at https://www.wisconsinfarmersunion.com/fairmaps
- 2. A documentary titled *Slay the Dragon* gives a very thorough history of how redistricting in WI was achieved behind closed doors in utter secrecy in 2011. It also follows a successful grassroots challenge to redistricting done in Michigan. There is hope for change! This documentary is approx. 2 hours long though it exposes the culprits who drew "election safe" districts in WI. I paid \$4.99 to watch it (rental for 1 month) on Amazon Prime. It is worth \$5 and your time.

GWI reminds States of their Commitment to Women as a Means to Building Sustainable Peace

On 21 September, GWI joins the international community in observing the International Day of Peace. The COVID-19 crisis has ravaged the entire world. Peace processes are upended in every geographical region. On International Day of Peace, established in 1981 by the United Nations (UN) General Assembly as a global day of non-violence and ceasefire, GWI seizes the opportunity to remind Member States of their commitment to the 2000 landmark UN Security Council Resolution 1325 that specifies the vital role of

women in peacebuilding and stresses the importance of their equal participation in all peacebuilding efforts. Aligning with this year's UN theme "Shaping peace together", GWI underscores that peace cannot be achieved without women's participation. Women represent a minimal share of the people involved in peace processes: they made up only 3% of mediators, 4% of signatories, and 13% of negotiators of peace processes between 1992 and 2018, according to UN Women. On the occasion of International Day of Peace celebrated annually on 21 September, GWI is releasing a press release urging Member States, institutions and peacebuilding organizations to include women as actors of peace on local, national, and international levels.

2 Win Nobel Prize In Chemistry For Developing Method For Genome Editing, from SCIENCE, 10/07/2020

French scientist Emmanuelle Charpentier and American Jennifer A. Doudna were awarded the prize

STOCKHOLM (AP) — French scientist Emmanuelle Charpentier and American Jennifer A. Doudna have won the Nobel Prize in chemistry for discovering one of gene technology's sharpest tools: developing a method of genome editing likened to "molecular scissors" that offer the promise of one day curing genetic diseases.

The recipients were announced in Stockholm by the Royal Swedish Academy of Sciences.

"There is enormous power in this genetic tool, which affects us all," said Claes Gustafsson, chair of the Nobel Committee for Chemistry. "It has not only revolutionized basic science, but also resulted in innovative crops and will lead to ground-breaking new medical treatments."

Gustafsson said that as a result, any genome can now be edited "to fix genetic damage."

Gusfafsson cautioned that the "enormous power of this technology means we have to use it with great care" but that it "is equally clear that this is a technology, a method that will provide humankind with great opportunities."

GWI at the 45th session of the Human Rights Council (HRC45)

HRC45 held at the Palais des Nations, Geneva. The session opened on 14 September and closed on 6 October 2020. GWI's <u>written statement</u> addressing HRC45 on Distance learning and digital technologies as a strategical and challenging turn towards inclusive access to education for women and girls has been accepted by the United Nations (UN) Geneva and is now available on the <u>GWI website</u>. The statement is co-signed by Canadian Federation of University Women, Federation of American Women's Clubs Overseas (FAWCO), Latter-day Saint Charities, International Federation of Business and Professional Women, Women-Graduates USA, and Zonta International, and stresses the need for governments to ensure that elearning will not broaden existing digital inequalities. GWI acknowledges the promising possibilities of dis-

tance learning as a means towards equal, safe and inclusive access to education for all and especially critical for women and girls. At the same time, however, GWI warns that implementing distance learning necessitates overcoming crucial challenges. The statement makes strong recommendations about dedicating resources to ensure decent learning conditions for all students displaced from their education, especially to women and girls.

Afghan mothers' names to be included on children's ID cards, from BBC News, 18 September 2020

Afghan mothers will have their names printed on their children's national identity cards, after a campaign to challenge taboos around women's names.

President Ashraf Ghani just signed into law an amendment long sought by women's rights campaigners. Until now, Afghan law dictated that only the father's name should be recorded on ID cards. Using a woman's name in public in Afghanistan is traditionally frowned upon and can be considered an insult.

Some women have suffered beatings for perceived indiscretions such as using their names to obtain prescriptions.

But a campaign launched three years ago under the hashtag #WhereIsMyName garnered high-profile support from celebrities and members of parliament.

It called for mothers' names to be included alongside fathers' names on national identity cards, and benefited from nearly two decades of progress on women's rights in Afghanistan since the toppling of the Taliban in 2001.

A social media campaign saw activists introduce themselves using their names and their mothers' names.

Laleh Osmany, founder of the #WhereIsMyName campaign, told the BBC Afghan service that she was "overjoyed" at the result.

"There is no doubt that this victory is the result of persistent campaign. The government also stood by the citizens, and I express my gratitude to the president himself and his deputies for their support and men and women who supported our campaign and raised their voice, and congratulate all equal rights campaigners on this victory."

The Afghan cabinet's legal affairs committee said "the decision to include the mother's name in the ID card is a big step towards gender equality and the realization of women's rights".

The decision came amid concern that progress could be set back in the coming weeks as the government attempts to reach a peace agreement with the Taliban.

Switzerland votes to create nationwide paternity leave, from The Hill, BY ZACK BUDRYK - VIA THE NEW YORK TIMES 09/27/20

Switzerland approved a voter referendum enacting paid paternity leave, The New York Times reported.

Swiss fathers previously were given a single day off after their children were born. Under the referendum, they will receive 10 days of paid leave, making Switzerland the last Western European nation to guarantee paid paternity leave.

Parliament approved the paternity leave mandate in 2019. But conservative Politicians collected more than 50,000 signatures opposing it, so Swiss laws required it be put directly to voters. About 60 percent of voters approved the measure, with French- and Italian-speaking parts of the country more likely to back it.

Any fathers using the leave will be entitled to 80 percent of their salaries, although companies will be given the option of extending the length of leave or increasing the salary percentage, according to the newspaper. The new law is set to take effect Jan. 1.

Patricia Purtschert, a gender studies professor at the University of Bern, noted that the law would only apply to biological parents.

"It does not apply to adoptive or same-sex parents," she said, according to the Times. "There are still quite a few people who are parenting that won't profit, from the start at least."

Switzerland has lagged beyond other countries in the region on women's rights and gender equality, only giving women the right to vote in 1971. Married women were required to obtain their husbands' permission to work outside their homes until 1988.

Women's issues at UN: Still 'too low down on the agenda'By JENNIFER PELTZ, Associated Press, SEPTEMBER 29, 2020

UNITED NATIONS — Addressing the U.N. General Assembly Bangladeshi Prime Minister Sheikh Hasina noted a milestone: the 25th anniversary of the Beijing women's conference that produced a global roadmap for gender equality and a ringing rallying cry that became part of the event's official declaration: "Women's rights are human rights."

The international community has "come a long way to ensure gender equality" since then, Hasina said, but "we need to strengthen our resolve and mutual cooperation."

Hasina didn't really have to say more to show that there was still a long way to go. She was one of nine women among the more than 180 presidents, premiers, monarchs and ministers who spoke at the planet's top diplomatic meeting this year.

While the U.N. is preparing for a separate summit to mark the anniversary of the landmark female empowerment plan, women's rights were a steady thread but hardly a top theme of leaders' remarks at the world body's signature assembly.

Some leaders took time to recall the 1995 conference, detail domestic initiatives or lament that progress toward female equality is lagging or even retreating. Yet with the coronavirus pandemic shoving numerous other issues out of the spotlight, many speakers gave the status of women and girls a passing mention, if any, even as the U.N. warns that the virus crisis is exacerbating gender inequities.

"If the General Assembly statements are a kind of snapshot into what the world is prioritizing at the moment ... this is too low down on the agenda," says Rachel Vogelstein, who runs the Council on Foreign Relations' Women and Foreign Policy Program.


