**Public Policy** update from Suzanne on gerrymandering; she and Barb Peterson met with a leader from the group Western Wisconsin for Non-Partisan Voting Districts to brainstorm ideas on how to get the word out on this issue. It's a non-partisan issue that needs attention to ensure that we have fair voting districts.

Possibilities: signs (talk to Cheryl Maplethorpe) to put in the yard for Menomonie and the 7 other counties on our side of the state.

A booth to distribute brochures at River Falls Days, jointly with the WW group and Pierce County GROW, a local group who can speak to the cause.

Also possible is to have at the same table the message on pre-printed, stamped postcards with room for people to add their name and address, ready to mail. There is still time to register and get a table for the reverse parade.

The call to action on this is to phone your senator or assembly person and tell them you want them to vote for fair non-partisan voting districts.

There is a State Public Policy toolkit that includes sample letters/ email scripts and talking points for calling or contacting your representatives.

See the St. Croix County League of Women Voters for more information on this issue.

**Program and format plans** - we need a group to work with the ideas generated at the May 11th meeting to find an overarching theme for next year's programs. Some possibilities: economic issues for women, equity/diversity or social justice issues. We need a group of people who have contacts and resources to assist with programming. Gwen will set dates for meet-

ing dates and times for this group. Going forward, a hybrid format for our meetings would make them more available to a larger number of people.

After discussion, we decided on a longer, bigger, celebratory social time at the opening meeting in September to better reconnect with one another in a more relaxed timing. There is much interest in a book discussion group. We have volunteers, Gretchen and Maureen, to work on choosing titles. Residence halls at UWRF officially opened on Saturday, August 28 for new students. New and returning students continued to move into the residence halls until the first day of classes on Thursday, September 2. Over 2100 students will live on campus this fall. While official enrollment numbers will not be available until after the start of the academic year, typically about 40% of the undergraduate student population lives in the residence halls. The age range of students living on campus this fall is from 17 to 32 years.

#### AAUW Newsletter – August, 2021 - Public Policy Article

Submitted by Barbara Peterson I'M PROUD TO BE PART OF AAUW by Barbara Peterson

I'm so pleased that AAUW-WI has prioritized fair mapping for redistricting in 2021. As a large and active group from across Wisconsin, we have more clout in asking our legislators to act on our behalf. Each of you has an opportunity to be an activist, supporting legislation that can effect redistricting for many decades. While AAUW considers fair maps a nonpartisan issue, political parties are using gerrymandering to their benefit. Both parties have done this. It must stop!

Jane Benson of Suamico, WI explained the situation well in the following article. I have taken the following comments from unsigned documents. I can't take credit for the wording but I think the facts are accurate.

#### IT ONLY HAPPENS ONCE EVERY TEN YEARS

"Every 10 years, the US census counts people, and political maps are re-drawn to account for changes in population. Maps include: municipal wards, county, state assembly and senate districts, and Congressional districts.

Wisconsinites face a difficult situation, because the 2011 maps were gerrymandered toward Republicans.

Gerrymandering skews results. For example, in 2018, 5 state-wide positions: Governor, Attorney General, etc. were ALL won by Democrats with more than 50% of the vote. Democrats won 52.99% total votes for the assembly, Republicans' 44.75%, but 63 assembly seats went to Republicans and 36 to Democrats. In 2020, Democrats elected Joe Biden President, but lost most district races.

The Republicans' "safe seats" allows them to ignore the people's demands. Legislative leaders often limit discussion and votes only on issues reflecting their partisan agenda. Governor Evers requested special sessions on how to handle the Covid19 crisis; expanding Medicaid to gain substantial federal monies and gun control. Legislative leaders subverted those efforts by refusing to address them.

In 2019, US Supreme Court held "partisan" or political-party gerrymanders are beyond the reach of federal courts, removing a significant voter protection. Wisconsinites have no right to binding referendums. Instead, 55 of 72 counties in the state (representing more than 80% of Wisconsinites) passed nonbinding referendums/resolutions by super majorities requesting legislators use a nonpartisan method to draw our 2021 maps. Despite this support, the legis-lature has done nothing.

Although the Governor's biennial 2021 budget proposed money for nonpartisan redistricting, the legislature stripped it from the budget. To establish a nonpartisan procedure, the People's Map Commission was formed, traveled to all 8 congressional districts, holding listening sessions, asking citizens how they think the maps should be drawn. Wisconsinites may submit proposed maps of their communities for its consideration.

2021 differs from 2011, because we have a split government: Democrat governor and Republican legislature. If the legislature ignores nonpartisan procedure and presents maps, Evers may veto them. If Evers' veto is sustained, litigation is likely and courts will draw the maps. This is costly and unnecessary.

To get the nonpartisan districting we have voted for and save unnecessary costs, contact your legislators demanding nonpartisan redistricting in 2021."

Thanks to Jane Benson for this fine explanation of the gerrymandering dilemma. The Census data was released August 12, which starts the process of redistricting in the legislature and also by The People's Map Commission. They are likely to draw significantly different maps.

Gerrymandering has also allowed the legislature to avoid hearings on critical issues like elections during COVID19, healthcare, reasonable gun control, and policing practices. Governor Evers called seven special sessions from 2018-2020 to address these issues, Republicans gaveled out of some immediately, while others that remained open were eventually gaveled out months later without action. An independent study identified the Wisconsin legislature as the least active full-time state legislative body in the country since states began taking measures to combat the COVID-19 pandemic. This gridlock will continue as long as legislators need not respond to the will of the majority.

But here is the good news. So many people like you are putting pressure on the legislature that they are taking notice. Will they dare to draw the districts out of the sight of the public and without hearings again this time? Maybe not. You have an opportunity to be heard again and again before it is too late! A teacher/activist is using open record laws to access and report the number of letters, emails and calls each legislator gets for and against this issue. These reports may be used in the court case that could follow redistricting maps.

Wisconsin deserves good government and fair representation. Demand Wisconsin's Legislature end partisan districting without delay. Write, call, email your legislators and demand that they address the issue of nonpartisan districting and support Legislative Bills AB395, (Assembly version)and SB389 (Senate version) creating nonpartisan redistricting.

#### Part of the All-Girls Robotics Team Flees Afghanistan, by Sarah Ruiz-

Grossman, Huffington Post, World News, 08/19/2021

As the Taliban quickly took over the country amid the U.S. military's withdrawal in recent days, many have raised concerns about women's rights in the nation, which were severely curtailed under the Islamist insurgents' rule from 1996 to 2001. At the time, girls were banned from school and women from work, and they were allowed out in public only if fully covered and escorted by a male relative. Though the Taliban has said girls will be able to attend school and women's rights will be respected "within the framework of Islamic law," many have expressed skepticism that girls and women will be allowed to live freely under the ultraconservative group's rule.

The all-girls robotics team rose to international fame in 2017, when the U.S. denied them visas to come to the country for a competition, then relented after public outcry and intervention by then-President Donald Trump. The girls won a medal at the contest for "courageous achievement." Members of the team had planned to leave Kabul on a flight, according to The New York Times, but their flight was canceled amid the chaos at the airport as thousands attempted to escape. The government of Qatar sent a plane and expedited visa processes to bring the girls to Doha, according to a statement from the Digital Citizen Fund, the team's parent organization. The United States, the European Union and other nations, (including Graduate Women International), said in a joint statement: "We are deeply worried about Afghan women and girls, their rights to education, work and freedom of movement. #### Athletes who show that sport and study go hand in hand

The results are in. Team USA's biggest Olympic winners are ... women. They made history in Tokyo, nabbing nearly 60% of all U.S. medals. Kate Nielson, AAUW

**Gabby Thomas**, is an American track-and-field athlete. She is the third-fastest woman of all time in the 200 metres with her result of 21.61 seconds, which was set at the 2020 US Olympic trials. She won an individual bronze medal and a team silver medal at the 2020 Summer Olympics in Tokyo. Thomas is African-American on her mother's side and Jamaican on her father's side. A graduate of Harvard University, she studied neurobiology and global health as an undergraduate. While at Harvard, Thomas won 22 conference titles across her three years of athletics in six different events, setting the school and Ivy League records in the 100 meters, 200 meters, and the indoor 60 meters. She signed a contract with New Balance and turned pro in October 2018, forgoing her last year of collegiate eligibility. After Harvard, she

moved to Austin, Texas. She is pursuing a master's degree at the University of Texas at Austin in epidemiology.

**Anna Kiesenhofer** (born in Austria, on 14 February 1991) is a **cyclist, mathematician and Olympian.** Kiesenhofer, studied a doctorate in mathematics at the Technical University of Vienna and the University of Cambridge in the United Kingdom. She is currently a postdoctoral fellow in mathematics at the École Polytechnique Fédérale de Lausanne (EPFL). (Wikipedia).

**Hadia Hosny** of Egypt, is the World No. 40 in women's doubles in badminton and a threetime Olympian. The 32-year-old is also a parliamentarian in Egypt in the Sport and Welfare committee. A professor at the British University of Egypt, she also holds a Master in Biomedicine at the University of Bath, UK, and has a Ph.D. In Pharmacology of El Cairo University.

**Charlotte Hym,** was born in Paris. She asked for a skateboard at the age of twelve because she saw so many people skateboarding in her local area. Hym was an undergraduate student at the Paris Descartes University, where she majored in sports science. After graduating, she started a master's program in neuroscience. She remained in neuroscience as a doctoral researcher, focusing on cognitive neuroscience. She looked at the impact of maternal voices on newborn babies.

**Louise Shanahan** (born 26 January 1997) is an Irish athlete. A graduate of the University of Cork in her native country, Shanahan is pursuing her PhD at the University of Cambridge in England. Her main interest is medical physics. She studies and develops devices that could improve cancer diagnosis and treatment.

Andrea Murez from Israel, is a swimmer who participated in 50, 100 and 200 meters freestyle and 4×100 mixed relays. Outside the pool Andrea is a biologist from Stanford University in the US.

**Nadine Apetz** is the first German boxer in an Olympics. She has received medals in European tournaments and in the World Boxing Championship. Nadine has a Masters in Neuroscience from the University of Bremen and hopes to complete a PhD at the University Hospital of Cologne. Apetz is studying a technique called deep brain stimulation, which involves applying electrical or electromagnetic currents to certain areas of the brain's "gray matter" – the goal, to help Parkinson's sufferers.

#### Ukraine Army Criticized For Making Female Cadets Parade in Heels Huffington Post, WORLD NEWS 07/06/2021

Ukraine's defense minister is under pressure from members of the government over the decision to have female military cadets wear pumps with heels in an important parade. "The purpose of any military parade is to demonstrate the military ability of the army. There should be no room for stereotypes and sexism," said a joint statement from three Cabinet members, including Minister of Veterans Affairs Yulia Laputina. It noted that about 57,000 women serve in the country's armed forces and "have proved their worth not in heels, but with machine guns." The military offered no explanation as to why female cadets were wearing a different type of shoe than male cadets.

## Canada Names 1st Indigenous Governor General, by The As-

sociated Press Reporter, July 6, 2021

OTTAWA — An Inuk leader who has served as a Canadian diplomat was named the country's first Indigenous representative of the crown on Tuesday — an announcement that comes in the wake of a scandal over the nation's long mistreatment of Indigenous people. The appointment follows the revelation that hundreds of unmarked graves of children have been found on the grounds of former residential schools across Canada — institutions to which Indigenous children were forcibly relocated for generations. Simon began her remarks by speaking in Inuktitut, and then in English thanked Trudeau for the "historic opportunity" saying she is" Honored, humbled and ready to be Canada's first Indigenous governor general."

Samoa welcomes 1st woman PM after court ends constitutional deadlock, by Gigi Suk, AXIOS, July 24, 2021

The Samoan court of appeals ruled that Mata'afa's Faatuatua ile Aua Samoa ua Tasi (FAST) party was the winner of the Pacific island nation's early April election that resulted in a tie.At the time, the two competing parties won 25 seats each in the 51-seat legislature, with the remaining seat held by an independent member. FAST's Mata'afa and the Human Rights Protection Party's Tuilaepa Sailele Malielegaoi, who had served as prime minister for more than 22 years, both claimed to be country's rightful leader, per NPR.

**What happened:** After the election, the Samoan electoral commission declared that an additional candidate from the HRPP, Ali'imalemanu Alofa Tuuau, won a seat in the legislature due to the requirement that a minimum of 10% of seats in parliament be held by women. The independent then backed FAST, deadlocking the legislature at 26-26. Samoa's Supreme Court ruled in May that the electoral commission's decision to add the extra seat was invalid, giving FAST the 26-25 majority.

**Why it matters:** This brings an official end to Malielegaoi's reign. At the time of the election, he was the world's second-longest serving prime minister, per the Guardian.

# You have often said that the Belarus opposition has a woman's face. What does that mean?

**SA:** I couldn't say that women composed the absolute majority of the protesters. Of the leaders, yes. I am certain that if men had been in charge of the revolution, there would have been bloodshed. Minsk was stuffed with military equipment, military troops were brought to the city, and young people were ready to fight for freedom. The merit of our revolution is that women did not allow bloodshed. I was against violent methods from the start. We did not win victory, but we vanquished the dictatorship morally. **Council 47th Session** On 21 July 2021, concluded its forty-seventh regular session with the adoption of 25 resolutions.

Promotion and Protection of All Human Rights, Civil, Political, Economic, Social and Cultural Rights, including the Right to Development, the Council adopted 25 resolutions including:

- Resolution (<u>A/HRC/47/L.1</u>) on "civil society space: COVID-19: the road to recovery and the essential role of civil society
- Resolution (<u>A/HRC/47/L.2</u>) on "menstrual hygiene management, human rights and gender equality"
- Resolution (<u>A/HRC/47/L.3</u>) on the "realization of the equal enjoyment of the right to education by every girl
- Resolution (<u>A/HRC/47/L.4/Rev.1</u>) on "the right to education
- Resolution (<u>A/HRC/47/L.18/Rev.1</u>) on "accelerating efforts to eliminate all forms of violence against women and girls: preventing and responding to all forms of violence against women and girls with disabilities

Indonesia's army stops 'virginity tests' on female recruits, By Niniek Karmini, Associated Press, August 12, 2021

Human rights groups are welcoming Indonesia's decision to stop abusive "virginity tests" on female army recruits seven years after the World Health Organization declared they had no scientific validity.

A spokesman for the Indonesian Navy, said, "It's not virginity test, but we call it obstetrics and pregnancy test." He said men and women were subjected to the same test. He added, "With these tests, we will know the complete condition of the navy officer candidate." Indan Gilang Buldansyah, a spokesman for the air force, described its test as a "reproduction health test" for male and female recruits. For women in particular, he said, the test is meant to ensure that "the recruitment candidate will have no problem in her education and placement." He said the discovery of a cyst could interfere with a woman's education. The tests still happen in other countries. In January, a Pakistani court banned their use by the police in sexual assault cases, saying the procedure was "used to cast suspicion on the victim." Afghanistan also banned the tests, without success. In Indonesia, many women have endured it. Women in the army and the wives of male soldiers were also subjected to the procedure.

Ethiopia confirms rapes 'without a doubt' in Tigray conflict, By CARA ANNA - Associated Press – 2/12/2021

Rape has occurred "conclusively and without a doubt" in Ethiopia's embattled Tigray region, the country's minister for women said in a rare government acknowledgement of the toll on civilians during 100 day of fighting. Tigray is a region of some 6 million people that remains largely cut off from the world. The minister's statement came hours after the Ethiopian Human Rights Commission in a new report said 108 rapes had been reported to health facilities in the past two months. The report said. "There is a possibility that the actual number of cases might be higher and more widespread than the reported cases."

Several witnesses have told The Associated Press about alleged rapes by Ethiopian soldiers or those from neighboring Eritrea, an enemy of the fugitive Tigray leaders and whose presence Ethiopia's government denies. "There are also disturbing reports of individuals allegedly forced to rape members of their own family, under threats of imminent violence," Pramila Patten said in the U.N. statement. "Some women have also reportedly been forced by military elements to have sex in exchange for basic commodities, while medical centers have indicated an increase in the demand for emergency contraception and testing for sexually transmitted infections."
